Charismatic Prayer Group***FRECKLES***

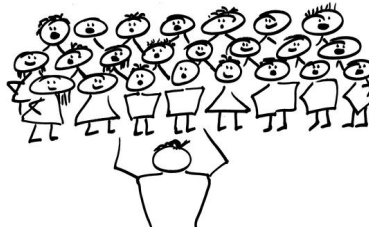

NYS Council of Catholic Charities Directors statement on the protection of people with special needs

Date posted: June 13, 2012

In the human services arena, the expertise, experience and advice of the Council of Catholic Charities Directors guides the New York State Catholic Conference, which in turn represents in matters of public policy the Roman Catholic Bishops of the eight dioceses of New York State. Catholic Charities and its affiliated agencies provide comprehensive services to people with special needs throughout the state, with a particular commitment to those who are vulnerable. The United States Conference of Catholic Bishops in their 2002 pastoral reflection, "A Place at the Table," restated the commitment to a respect for the dignity of all of God's children, saying, "The Gospel and Catholic social teaching place our service of the poor and vulnerable and our work for justice at the center of Christian witness."



The Council strongly believes that a key measure of any society is how the most vulnerable members are cared for; those with the greatest need are due special attention. In fact, the Bible tells us that we will be judged by how we treat the most vulnerable.

The Governor's Special Advisor on Vulnerable Persons, Clarence J. Sundram, recently produced a report appropriately entitled . The report examined the problem of abuse and neglect of vulnerable people in residential programs operated or supported by six separate state agencies. It identified gaps and inconsistencies in the system and made recommendations for rectifying existing problems.

Based upon this report legislation has been introduced by the Governor to increase safeguards for people with special needs. One component of the legislation would be the creation of a new state agency to be called the Justice Center for the Protection of People with Special Needs.

The Senate has already passed the Governor's bill. We are aware that there are discussions continuing with the Assembly. We are optimistic that the issues of the appropriate independence and transparency of the proposed new entity will be reached. It is critically important that there be proper checks and balances to ensure that these reforms are effective, efficient and fair to all involved, thus best promoting high quality care of vulnerable New Yorkers.

We anticipate that this important legislation will be passed before the end of the legislative session, scheduled in the immediate future. Persons with special needs who are in residential programs deserve decent, personalized care and human support. Our agencies and direct care workers do an outstanding job. It is important to find ways to recognize this good work while at the same time ensuring proper protections are in place to prevent and deal with abuses. The role of direct care staff in the provision of services is central to the quality of care. Our Council enthusiastically supports these efforts and the attempt to provide greater protections and respect for the innate dignity of vulnerable people with special needs.

Letter from the Pastor

On April 12, 2012, the Ad Hoc Committee on Religious Liberty of the U.S. Conference of Catholic Bishops (USCCB) issued a document, ***“Our First, Most Cherished Liberty,”*** outlining the bishops’ concerns over threats to religious freedom both at home and abroad. The bishops called for a **“Fortnight for Freedom,”** a 14-day period of prayer, education and action in support of religious freedom, from June 21 – July 4, 2012.



The fourteen days from June 21 – the vigil of the Feasts of Saint John Fisher and Saint Thomas More – to July 4, Independence Day, are dedicated to this “Fortnight for Freedom” – a great hymn of prayer for our country. Our parish, under the leadership of Father Henry and our Respect Life committee, have distributed handouts at our Sunday Masses that speak to this threat to our religious liberty under the recent decision by the Federal government to force religious institutes to fund aspects of the new health care law that go directly against the norms of the Catholic Church. This is not an issue about preventing birth control—it is an issue of whether the government can force people to act against their beliefs, which is a violation of the first amendment of the U.S. Constitution.

We plan here at St. Martin’s to seek to continue to distribute information about this serious concern. Also during the Fortnight for Freedom, we will have a special prayer said at our Sunday and daily Masses.

I received a polite and thoughtful letter from a visitor to our parish who felt that inserting such materials in our bulletin was too political and that it might even be a violation of our tax exemption. This is part of my response to that letter:

I believe it would be wrong for a church in the United States to tell people for whom they should vote. I think that the people would reject it and be offended by such an approach. The flyer you speak of does not say anything about for whom people should vote.

It speaks about an important issue to all Americans, as protected by the Bill of Rights - freedom of religion. I do not think people should be forced to go against their consciences in violation of their religious liberty. The Catholic Church has spoken on many topics such as war and peace, unjust labor practices, racism, poverty and homelessness, the death penalty, and unjust immigration laws. Many would consider them political issues. I do not believe in a religion that only is practiced in church on Sunday. A church should offer its values to her people and let them decide how they want to vote and act in their day to day lives.

In my experience, not all employers give health insurance. I suppose that is why it is called a ‘benefit.’ I wish my health insurance paid for my dental bills; it does not. I wish it would cover weight loss programs; it does not. I do not expect the Federal government to step in and demand my coverage to do so.

Should the Federal government demand the Amish to go to war if it is against their consciences? Should the Federal government serve pork to Jewish and Muslim prisoners and demand they eat it or starve? Should the Federal government decide how many children are enough for a person to have? Should the Federal government decide what medical services will be provided for me and what will not?

Institutes are given tax-exemptions because the government believes that the institute is serving the greater good of the society. Certainly, I invite you to visit our food pantry here and see how many people we serve during a week. Our schools are educating many children without federal aid. This is a great savings for the government. Our hospitals and hospices are providing many services to those in need. That is why we have a tax-exemption. If the choice is between tax-exemption or conscience, I hope the churches would choose conscience.

Dr. Martin Luther King preached civil disobedience from his pulpit. Would you wish his tax exemption were taken away? Bishop Oscar Romero preached against injustice from his pulpit and was martyred. Pope John Paul II spoke against communists when they ruled the government of Poland. Should he have been silent? Rosa Parks refused to sit in the back of the bus when it was the law. I am glad she opposed an unjust law. Not all laws are good and some demand to be challenged. I believe that is what the Catholic Church is doing in this case that concerns you.

Thirty Catholic Dioceses and Colleges, including Notre Dame University, have gone to Federal Court to challenge this ruling made by the present administration. So, I presume the IRS was aware of this issue before your letter.

Notes from the Pastor

Triduum to Our Lady of Perpetual Help
Wednesday, June 27 is the feast of Our Lady of Perpetual Help. As you know in 1866, Pope Pius IX entrusted the icon to the Redemptorists with the words: ***"Make Her Known."*** **On Monday, Tuesday, and Wednesday, June 25, 26, and 27, we will have a Triduum of prayer and reflection that will begin at 8:30 a.m. before the scheduled 9:00 a.m. Mass.** The Triduum will consist of prayers to Our Lady and a reflection on the icon. Parishioners are welcome to place flowers in front of the icon during the Triduum as a way of honoring Our Lady of Perpetual Help. **On the actual feast day (6/27) after the 9:00 Mass, we invite you to a festive breakfast in the Parish Hall.** The level of festivity will depend on the quality of the breakfast delights that you bring.

Holy Hour: There will be a Holy Hour before the Blessed Sacrament on ***Tuesday, June 26 from 3:00 p.m. to 4:00 p.m.*** You are invited to attend all or any part of the Holy Hour.

Financial Report:

Since the fiscal year for the parish ends in August, the annual financial report of the parish will be given to the parishioners this September. There was no report last September since I had just arrived.

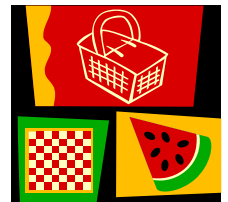
